The Michigan Constitution recognizes and protects many important rights we all hold dear, such as free speech and freedom of religion. - ensures Michigan's government officials are constitutionally obligated to equitably protect our environmental rights and Michigan's natural resources for the benefit of all people regardless of race, ethnicity, wealth, geography, or generation; and
- supports the ability of communities to advocate, and when necessary to go to court, to protect from government infringement, our environmental rights and the quality of our Michigan environment.
